DESIGNATION OF ADMIN DUTIES TO ADMIN CADRE

Respected Sir,

1. With reverence the Association submit the following for your kind consideration and necessary action please.
2. It need no emphasis that Admin Cadre is the back bone irrespective of the department, but it is very unfortunate to say that in our department this Cadre has been downgraded and disregarded at every step. Admin duties right from top to bottom are designated to non-admin cadre officers. This ad hoc induction of technical executives on Adm Jobs is stretching the responsibility of their immediate subordinate clerical supervisors and becoming counter productive by lowering decision making standards and confusing responses. Employing civil/Mech/Elect Engrs, BS & TO on such data operating jobs is de facto wastage of their technical and professional talent of specialization. The experiment of deploying of Civ Technical officer and B/S Cadre officer, who are considered unsuitable for Tech. Jobs on Adm duties, has also failed to steer the rot in MES administration. These categories officers are very few and their own designated posts are lying unmanned. The experiment was resorted to because of an alarming shortage of professional qualified and experienced Administrative officers at senior level during the last so many years. Therefore, rejuvenation of the Adm. Cadre is not only necessary for career planning of the cadre, but also its an imperative requirement to manage administrative functions smoothly and measure unto the challenges and changes of the future.
3. Recently cadre reviews of AE/JE and BS Cadre have been implemented and their appointments have been designated very clearly. Though there is no provn in the exiting policy to depute the Engrs, B/S Cadre and TOs to assign with the admin duties and the same is clear cut violation of policy devised by the GOI.

c) Other Cadre officers may please be removed from admin Cadre posts and posted to their designated appointment.

d) The department has sufficient experienced and professionally sound Asst. Admin Officer, whose services can be utilized as Adm officer from top to bottom (E-in-C's Br., CE Commands, Zonal CEs, CWEs GEs and AGE (I) Level. It is time to amend the E-in-C standing order so that each and every professional cadre can do the proper duty of their respective cadre. Meanwhile necessary directions may please be issued to the lower formation to utilize the services of Asst. Admin Officer as an Adm officer without any financial effect as per para 14.2 of E-in-C standing order (Copy enclosed for instant reference).
