**POSTING ORDER NO : MES/ 09 /2018 DT 24 May 2018**

3. Departure/arrival of the officer will be reported to this HQ (E1B/MIS ADP/MIS (Civ) by signal/fax by the relieving/receiving unit on the day of their SOS/TOS. **Movement order of officer will also be sent to this HQ within 48 Hrs from the date of issue of movement order.**

4. APAR of the officers will be initiated soon after their SOS date, if they have completed three months or more in the current APAR year under the reporting officer.

5. It will be ensured that the officer is not involved in the following before placed in higher appointments as envisaged in Govt of India Department of Personnel and Training OM No 22011/4/91-Estt(A) dated 14 Sep 1992.

**Govt Servant under suspension.**

(a) Government servants in respect of whom a charge sheet has been issued and the disciplinary proceedings are pending and.

(b) Government servants in respect of whom prosecution for a criminal charge is ending and.

(c) Before placing in position on promotion it should be ensured that officers are not involved in any disciplinary / SPE/Vigilance cases.


6. Before moving the officer to sensitive appointment, the provisions as envisaged in Govt of India, department of personal training OM No 11012/2007-Estt (A) dt 14 Dec 2007 shall be strictly adhered to. Disciplinary cases shall invariably be referred back to this HQ.

7. DGN Particulars of the officer will be sent to this office (E1B) along with his/her full name and present permanent rank.

8. The officer is required to exercise option in terms of fundamental rule 22 within one month from date of promotion. This aspect shall be mentioned in the movement order.

9. The unit indicated in column "From" are as obtained from respective HQ Commands as per their records. In case of variation in respect of column "From" the same may be corrected by concerned unit and movement order be issued accordingly and the same may be informed to this HQ.

10. Before relieving the officer, the head of the office will ensure submission of AIPR year ending Dec 2017 by the officer. In case of non submission of AIPR, the same will be intimated immediately to this HQ for placing the officer to non-sensitive appointment and taking action against him as per DOP&T guidelines.
